SUMMARY OF APPORTIONED GENERAL FUNDS

The General Council on Finance and Administration and the Connectional Table agreed on a quadrennial budget of \$603.1 million to submit to the 2012 General Conference for the seven general apportioned funds. The **SUMMARY OF APPORTIONED GENERAL FUNDS** table provides a comparison summary of the allocations among the seven funds for the coming quadrennium and the current quadrennium. More detail on the activities supported by the seven funds and the allocations within some of the funds is described in the series of reports provided on this site.

It should be noted that this is the first time the proposed quadrennial budget reflects a decrease in current dollars over the previous quadrennium.
